

Regulation No. 82 of the Rector of the University of Lodz of 20.01.2025

on recruitment schedule and admission limits to the Bio-Med-Chem Doctoral School of the University of Lodz and Lodz Institutes of the Polish Academy of Sciences for the academic year 2025/2026

Pursuant to Article 23(1) of the Act of 20 July 2018 Law on higher education and science [*Prawo o szkolnictwie wyższym i nauce*] (consolidated text Journal of Laws of 2024, item 1571, as amended) as well as Section 3(1) and Section 3(4) of the Recruitment Rules for the University of Lodz Doctoral School of Social Sciences for the academic year 2025/2026, adopted by Resolution No. 31 of the UL Senate of 17 December 2024, it is ordered as follows:

Section 1

The recruitment schedule for the academic year 2025/2026 for the Bio-Med-Chem Doctoral School of the University of Lodz and Lodz Institutes of the Polish Academy of Sciences (including for candidates whose doctoral scholarship will be financed in whole or in part from external funds) shall hereby be specified:

* applies to candidates who have been admitted to the recruitment procedure despite the fact that they do not hold a Master's degree (on the basis of Section 2(2) of the Recruitment Rules) and who have made a commitment to provide a certificate of having passed the diploma examination and having been awarded the Master's degree, within the time limit specified in the recruitment schedule

** in the case of candidates who entered the reserve list for the industrial doctoral programme (doktorat wdrożeniowy), the announcement of results will follow the deadline from the Ministry's Communication binding during the programme intake

Section 2

1. Admission limit to the Bio-Med-Chem Doctoral School of the University of Lodz and Lodz Institutes of the Polish Academy of Sciences for the academic year 2025/2026 is 36 persons. This quota is divided by scientific disciplines. Limits for particular disciplines are as follows:

Discipline	Admission limit
biological sciences	12
medical sciences	12
chemical sciences	12

2. The admission limit to the Bio-Med-Chem Doctoral School of the University of Lodz and Lodz Institutes of the Polish Academy of Sciences (without breakdown by discipline) for the academic year 2025/2026 for candidates whose doctoral scholarship will be financed in whole or in part from external funds is 20 persons.
