Rules of the Children's Day Family Picnic

organised on 3 June 2022 on the premises of the Academic Sports Club (AZS), ul. Lumumby 22/26, 91-404 Łódź

§1. General provisions

- 1. The family picnic, hereinafter referred to as the Picnic, will take place on 3.06.2022 from 3:00 p.m. to 7:00 p.m. on the premises of the Academic Sports Club at ul. 22/26 Lumumby in Łódź (map attached), within the area designated by the Organiser.
- 2. The Picnic is organised by the University of Lodz (UL). Co-organisers of the Event are: Academic Sports Club (AZS) and the Polish Teachers' Union (ZNP), jointly referred to in the hereby Rules as the Organiser.
- 3. The Participants of the Picnic are employees (also former employees) of the University of Lodz together with their children and guests from Ukraine residing in the University of Lodz Dormitories.
- 4. The Rules of the Picnic, hereinafter referred to as the Rules, are addressed to all persons who will be present at the Picnic. Every person staying at the Picnic during its duration is obliged to comply with the provisions of the Rules and the instructions of the Organiser and the security service.
- 5. The Picnic Organiser ensures the safety of the Picnic Participants and order during the Picnic, among others, by providing a protection service personnel distinguished by clothing items, having an identifier placed in a visible place and medical protection. The medical assistance point is located in front of the Academic Sports Club (AZS) building, next to the sports stadium.
- 6. The Participant of the Event (visitor) is obliged to read the hereby Rules.
- 7. The Organiser shall not be held liable for any events and consequences arising from ignorance and failure to comply with the provisions of the hereby Rules.

§2. Rights and obligations of the Picnic Participants

1. Participation in the Picnic is free of charge and is addressed to the employees of the University of Lodz and their children, as well as Ukrainian citizens and their children, who, due to hostilities, have been on the territory of Poland and reside in the facilities of the University of Lodz, subject to point 11 of this section.





- 2. Minors can only stay at the Picnic under the care of their parents and legal caretakers. They participate in the Picnic and take advantage of the prepared attractions under the sole responsibility of their parents or legal caretakers.
- 3. All the Participants are obliged to behave in a manner that does not threaten the safety of others, in particular to comply with health and safety rules, and the provisions of the hereby Rules.
- 4. The Picnic Participants are obliged to follow the Organiser's and security service personnel's orders.
- 5. In the case of placing devices such as inflatables in the Picnic area, they can only be operated by authorised persons or under their direct supervision.
- 6. It is forbidden to bring into the area of the Picnic, to possess and use by the Picnic Participants: weapons or other dangerous objects, explosives, pyrotechnics, fire hazardous materials and bring and consume alcoholic beverages, narcotic or psychotropic substances.
- 7. Smoking tobacco products is prohibited on the premises of the Academic Sports Club (AZS).
- 8. In the Picnic area, it is forbidden to conduct any commercial, promotional, advertising or political agitation without permission of the Organiser.
- 9. The area of the Picnic is prohibited for persons:
 - a. under the influence of alcohol, narcotic, psychotropic or other substances with similar effect,
 - b. who behave aggressively, provocatively, or otherwise posing a threat to the public safety or order.

10. In addition, it is prohibited:

- a. to use the equipment located on the premises of the Event in a way that is incompatible with its intended purpose and to destroy equipment used to organise the Picnic, including markings and information boards,
- b. to enter places or posts fenced off without the prior consent of the Organiser or the supervisor of a given post,
- c. to block roads and escape passages with cars, bicycles or other vehicles or equipment, under threat of towing the vehicle at the expense of its owner or removal of the equipment by the Organiser's security services,
- d. to behave in a provoking manner or causing disturbance of the order and safety which may result in a conflict, to behave in an abusive or offending manner,
- e. to perform any activity likely to endanger the life, health or safety of persons on the premises of the Event, and in particular to throw some objects,
- f. to litter the grounds of the Event.





The Picnic Organiser may refuse entry to the Picnic to persons who do not comply with §2 (3)

- 11. Persons who will not comply with the provisions of §2 (2-10) will be removed by the security services from the Picnic.
- 12. In the event of noticing fire or other threat to health, life and property, the Participants should:
 - a. immediately notify the security service or the Organiser,
 - b. comply with the instructions of the security service or the Organiser,
 - c. leave the Picnic area in the manner indicated by the security service or the Organiser.
- 13. If the Organiser designates safety zones, the Participants should use only the designated areas.
- 14. The Organiser shall not be held liable for items of value, money and other items of the Picnic Participants if they have been stolen, lost or destroyed due to the Participant's fault.

§3. Use of image

- 1. The Organiser and the persons designated by the Organiser may record the course of the Event for the purposes of documentation and promotion or advertising of the Organiser's Event.
- 2. The image of persons taking part in the Event can be perpetuated and then disseminated for documentation, reporting, advertising and promotional purposes.
- 3. University of Lodz reserves the right to use the photos of persons taking part in the Event taken during the Event in promotional, information and documentation materials,
- 4. The Event Participants acknowledge that participation in/joining the Event is unambiguous with granting their free consent to record, photograph, film or otherwise record their image in connection with the Event and to broadcast, distribute or show the image and voice recorded during the Event in connection with any programme depicting the Event. The legal basis for image processing is permission to disseminate the image, referred to in Article 81 of the Act on Copyright and Related Rights.
- 5. The obtained personal data in the form of their image will be subject to the processing by the administrator (controller). The Administrator (Controller) of personal data is the University of Lodz, ul. Narutowicza 68, 90-136 Łódź.

- 7. The personal data is processed only for the purposes related to the participation in the Event, its promotion and for the purpose of holding and adjudicating competitions or other events organised during the Event (used on site to identify winners of competitions and to present awards to the minors).
- 8. Personal data will be stored for the period required by legal provisions.

§4. Final provisions

- 1. The Organiser reserves the right to change the course of the Picnic for legitimate reasons, e.g., force majeure (e.g., weather conditions, general hazards arising).
- 2. The Organiser reserves the right to cancel the Picnic without prior notice and shall not be held liable for any compensation on this account.
- 3. In the case of doubts regarding the content of the hereby Rules, its explanation is solely up to the Organiser.
- 4. The hereby Rules are available in the Organiser's office, on the Organiser's website: www.uni.lodz.pl and at the entrance to the Picnic/AZS area.
- 5. University of Lodz shall not be held liable for all events and consequences resulting from ignorance and failure to comply by the Event Participants with the provisions of the hereby Rules.
- 6. The Organiser reserves the right to make changes without having to change the provisions of the hereby Rules, including safety guidelines.
