Information clause

Pursuant to Article 13(1) and 13(2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: GDPR) we would like to inform you that:

- 1) The Administrator (Controller) of your personal data is the University of Lodz, with its registered seat at ul. Narutowicza 68, 90-136 Łódź, hereinafter referred to as: "Administrator (Controller)";

the personal data provided by you is processed in order to organise and conduct a **Competition for**

scholarships for researchers from Ukraine

- 3) the legal basis for processing is Article 6 (1)(a) and (c) of GDPR (processing on the basis of your consent to the processing of personal data and in order to fulfill the legal obligation incumbent on the Administrator/Controller);
- 4) providing personal data is voluntary, but necessary to achieve the purpose referred to in point 3;
- 5) the personal data specified in the application will be processed, available in the Employee's Knowledge Database in the Employee Service (Portal Pracowniczy), the recipients of your personal data are persons authorised by the Administrator (Controller) who organise and conduct the Competition and persons authorised to obtain personal data on the basis of legal provisions;
- 6) your personal data will not be transferred to a third country/international organisation, unless it is required by the legal obligations of the Administrator (Controller);
- 7) your personal data will be processed and stored for the period necessary to achieve the purpose stipulated in point 3, but no longer than it is required by the internal regulations in force at the University of Lodz;
- 8) you have the right to access your personal data and the right to: rectify, delete (if legally permissible), limit processing, transfer, object, and at any time withdraw consent without affecting the lawfulness of processing which was made on the basis of consent before its withdrawal;
- 9) if you deem the processing of your personal data violates the provisions of GDPR, you have the right to lodge a complaint with the supervisory body, which is the President of the Personal Data Protection Office;
- 10) personal data is not processed for any purpose other than the purpose for which the personal data was collected;
- 11) your personal data in relation to the implementation of the purpose stipulated in point 3 will not be processed in an automated manner, including in the form of profiling.
