

## RELAXATION AREA RULES AND REGULATIONS

## § 1

- The Rules and Regulations define the purpose and rules of using the Relaxation Area of the Academic Support Centre of the University of Lodz.
- 2. Persons staying in the Relaxation Area are required to read the Rules and Regulations, and comply with its provisions.
- 3. Entering the Relaxation Area is equivalent to accepting the Rules and Regulations.
- 4. The content of the Rules and Regulations is provided by the employees of the Academic Support Centre and available on the website of the Academic Support Centre.

## § 2

- The Relaxation Area is located on the premises of the Academic Support Centre of the University of Lodz. It is open at times specified in the schedule.
- 2. The management of the Academic Support Centre of the University of Lodz reserves the right to change the opening hours or completely close the Relaxation Area on certain days.
- 3. Students, PhD students and employees of the University of Lodz are entitled to use the Relaxation Area.
- 4. With the consent of the head of the Academic Support Centre, in justified cases, other persons are also entitled to use the Relaxation Area.
- 5. The Relaxation Area is a monitored area or the Relaxation Area Rooms are monitored. The image is recorded, stored and processed. A person entering the Relaxation Area allows the registration, recording, storage and processing of the image for security, documentation, information and reporting purposes in accordance with the applicable law.
- 6. The condition for entering the Relaxation Area is registration at the Academic Support Centre and signing the attendance list.
- 7. Before entering the Relaxation Area, you should take off your shoes. You should enter the Relaxation Area wearing socks.

- 8. The Relaxation Area is a noise-free area. It is forbidden to use cell phones and music players in a way that disturbs the peace of other Relaxation Area users. No loud conversations are allowed in the Relaxation Area.
- 9. The Relaxation Area is a smoke-free area. It is completely a non-smoking area.
- 10. In the Relaxation Area it is forbidden to:
- a) stay, if a person is under the influence of alcohol or other intoxicants,
- b) bring and consume alcoholic beverages or other intoxicants,
- c) bring and consume food and drinks,
- d) bring animals,
- e) cause situations that threaten the safety of one's own or other people,
- f) destroy the equipment of the Relaxation Area,
- g) take equipment from the Relaxation Area outside.
- 11. In the event of noticing any irregularities or breaches of security, the employees of the Academic Support Centre should be notified immediately.
